

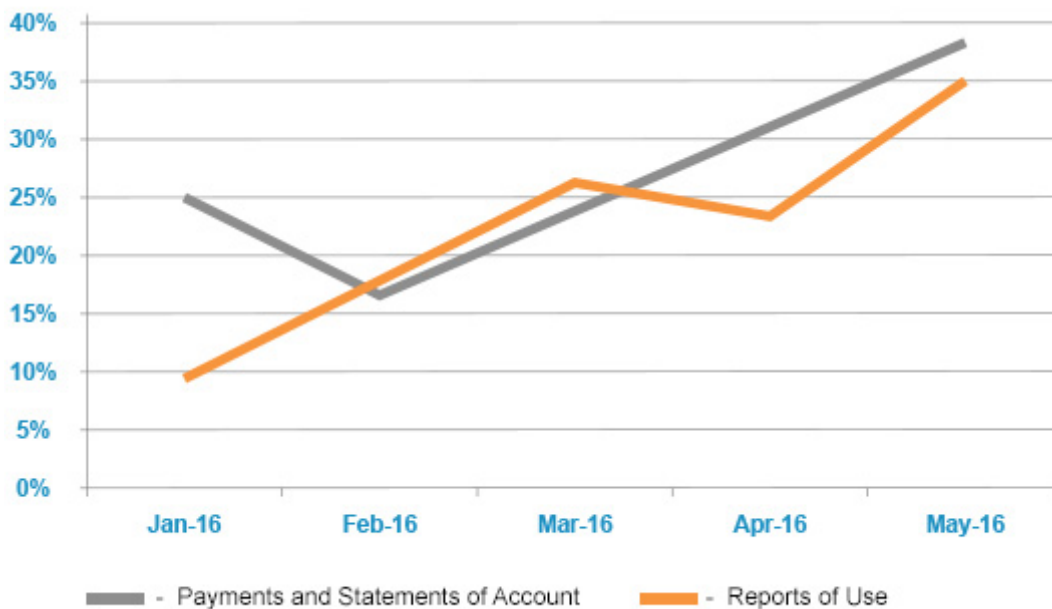
Have you recently received an email from us regarding your submissions?

While the majority of licensees get their submissions right the first time, we recognize that sometimes "things happen" and submissions may have errors or discrepancies, or sometimes they don't reach their intended destination: SoundExchange. Our License Management team is spending the next couple of months reviewing past royalty submissions from services that send us monthly royalties and Reports of Use, and reaching out to those from whom we've received items that have issues, or from whom we may be missing items, or even both.

So, if you haven't heard from us yet, this would be a great time to take a few minutes to double check your own history of royalty submissions. If you uncover your own discrepancies, or have questions, please contact us at LicenseeRelations@soundexchange.com and we'll work together to get things back on track as quickly as possible. Spending a few minutes now to do your own "health check" on your statutory licensing compliance will save time for you and us in the long run, so we thank you in advance!

More services are using SoundExchange Licensee Direct than ever!

Since last spring, the amount of submissions using Licensee Direct has increased from none (since it didn't exist!) to almost 40% of everything we receive.

Services using our *free* online portal are able to:

- calculate their royalties owed online, lessening the chance for errors
- certify their royalties owed online, removing the need to physically sign a paper form, or email a scanned PDF
- make online payments, using a credit card or electronic withdrawal from a checking account, with no additional fees
- upload Reports of Use, confirming that we have received your playlist with audience measurement
- view past transactions, and download PDF copies of previously certified Statements of Account
- participate in ROU Augmentation, which separates out recordings which were reported incorrectly and supplies missing ISRC information for certain recordings
